CFA SOCIETY OF THAILAND- 2009-2010 SOCIETY SCHOLARSHIP PROGRAM:

CFA Society of Thailand, a member chapter of CFA Institute, is the new non-profit organization establishing to be the center of communication among all of CFA members and CFA candidates in Thailand. We would like to inform all prospective scholars that CFA Institute with assistance from CFA Society of Thailand is pleased to offer the 2009-2010 Society CFA Scholarship Program to all interested persons in Thailand. The society scholarship is for the interested persons who want to take the CFA examinations in **June 2010**. If you are one of them, please carefully read the below information on who, what and how to apply for this society scholarship:

WHO IS ELIGIBLE FOR THE THAI SOCIETY SCHOLARSHIP?

1. Everyone who holds the bachelor's degree and is residing in Thailand **or**
2. Students attending a college or university in Thailand and expect to graduate with a bachelor degree or equivalent no later than 31 December 2010.

The prospective scholars must fulfill all CFA candidate requirements to register. Please note that immediate family members of the society's officers and directors are not eligible.

WHAT IS THE VALUE OF THIS SCHOLARSHIP?

The scholarship recipients will receive the waiving of the registration fee and discounting on the normal enrollment fee regardless of the level he or she applies. The scholarship recipients **pay only US\$225** for the exam (to cover the cost of the curriculum).

HOW MANY SCHOLARSHIPS DOES CFA SOCIETY OF THAILAND OFFER AND WHAT ARE THE SELECTION CRITERIA?

CFA Society of Thailand will award a maximum of ten (10) scholarships. Our criteria are based basically on **financial need, scholastic grades** and/or **an essay on why prospective scholars would like to enter the CFA Program**.

IF I HAVE ALREADY REGISTERED AND ENROLLED FOR JUNE 2010 CFA EXAM, CAN I STILL APPLY FOR THE SCHOLARSHIP?

You still can apply for the scholarship. And, if you receive this scholarship, CFA Institute will refund the money less the **US\$225**.

WHAT WOULD I DO IF I WOULD LIKE TO APPLY FOR THE SCHOLARSHIPS?

1. Check whether you fulfill all CFA requirements. Read instructions in application form carefully.
2. Complete the application form and essay
3. Send the application form & supporting document to CFA Society of Thailand by **30 December 2009**
4. Selected scholarship applicants will be interviewed by a panel of directors in mid January 2010 (only short-listed applicants will be notified for interview)
5. Final Society Scholarship recipients will be announced in early February

HOW CAN I GET THE APPLICATION FORM?

- Register online via the given Web link.
- RE: **"Registration for 2009-2010 Society Scholarship and Request for Application Form"**.
- Once registered, you will be immediately acknowledged by a confirmation email.
- You will receive an email with the Application Form within a week after the confirmation above.
- **NOTE:** You must use the given Application Form (in **doc format** only).

And follow all other the instructions as given
